# TAC Meeting of the Palouse RTPO

## Tuesday, August 22, 2023

## MINUTES – meeting held via ZOOM

- Welcome Call to Order/Introductions. James Wege Garfield County; Kevin Poole, City of Clarkston; Sean Wells, City of Pullman; Paul Gonseth, WSDOT SC; Rebecca Couch, Palouse RTPO Staff
- 2. **Approval of meeting minutes from May 23, 2023.** Sean moved to approve. James seconded. Minutes approved as presented.
- **3. Regional Transportation Improvement Plan (RTIP) 2023-2028.** Review 2022-2027 RTIP for necessary updates. Rebecca shared the list of projects included in the 2022-2027 RTIP and asked agencies to send any updates to her. RTIP will be updated for TAC and board approval in September.

## 4. RTPO Updates/Comments

- a. Whitman County/City of Pullman Freight Alternative Study. No updates from WSDOT regarding funding from their agency. Rebecca submitted the project to the Rural and Tribal Assistance Funding Pilot Program on August 14.
- b. **Census Urban Area Boundary Adjustment process.** Only applies to City of Pullman within the RTPO. Sean and Rebecca will connect at a different time to determine what needs to be done. Need to submit shapefile to WSDOT with request for adjusted boundary. Paul explained that now is a good time to smooth the boundary line, adjusting to address where roads exit the boundary (and are designated rural) only to re-enter the boundary (and have urban designation again).
- c. **WSDOT Highway System Plan.** Rebecca asked if a presentation from WSDOT would be of use to the TAC, or if the TAC felt it was relevant to have a presentation before the Policy Board. There was no interest expressed.

### 5. Member comments relative to the RTPO

- a. **Project Updates from Member Agencies.** City of Pullman, City of Clarkston, Garfield County, and WSDOT SC provided general updates.
- 6. Adjourned at 10:30 a.m. next meeting scheduled for November 28, 2023.
